

Focus on safety - every day

Are you and your team following your operating procedures every single day? It pays to regularly ask yourself if you are operating to (at least) agreed operating procedures even when you are at your busiest, when the weather is most difficult, with your most challenging clients.

Activity Safety Guidelines reviews

WorkSafe NZ is responsible for managing the regular reviews of our [Activity Safety Guidelines](#) (ASGs). Canyoning, Caving, Coasteering, and Abseiling were due for review last year, however this did not occur. TIA has raised this with WorkSafe NZ who have resolved to get the reviews underway.

Operators in those sectors should expect to receive a questionnaire asking whether you think the good practice information in the ASG is still current, and if not why not. Please take a moment to answer the questions. If information needs updating a more focused review will gather the correct information.

Ideally each ASG is reviewed every three or four years. To date reviews have resulted in only minor changes. ASG changes will be notified in this newsletter and on the [SupportAdventure website](#).

Good Practice Guidelines - more on the way

There are now nine [Good Practice Guidelines](#) with more on the way. GPGs are designed to address common outdoor activities that are not covered by the [Adventure Activity Regulations](#) or the ASGs.

Work is underway on:

- Orienteering/rogaining, trail running and adventure racing
- Snorkelling and free diving
- Coastal and surf activities

Rafting regulation

While Maritime New Zealand are the regulators for rafting, we have confirmation that this will change and rafting will come under WorkSafe NZ and the Adventure Activity Regulations. TIA and NZ Rivers Assn have met with WorkSafe NZ and MNZ to discuss what will be required to make this change.

We will work with the regulators to ensure that operators are given plenty of information and lead-in time, and that industry continues to drive the rafting qualifications and good practice requirements. We will keep you updated through this newsletter and NZ Rivers Assn and TIA channels.

An auditor's view on where we're falling short

Emergency help in remote areas

We've been hearing for some time how hard it is for providers of activities in remote areas to get the right kind of help in an emergency situation. Dialling 111 isn't always feasible and activating the right part of the 111 system isn't always as simple as it seems.

These new [good practice guidelines](#) will help you know what to do. The guidelines have been produced by New Zealand Search and Rescue with the assistance of Recreation Aotearoa and in consultation with NZ Police, Ambulance Services, the Rescue Coordination Centre NZ, TIA and a variety of activity providers.

NZOIA National Training Symposium 2019

The Symposium encourages the continual professional development of leaders, instructor and guides. It has a practical focus and aims to enable delegates to revalidate, train, upskill and network all in one package.

Qualifications update

NZOIA Canyon Leader

Eight canyon guides have completed the first [NZOIA Canyon Leader](#) assessments. The holder of this qualification can lead and manage trips of up to four hours duration in easy vertical and aquatic canyons in normal conditions. In

addition, the canyon leader can assist a NZOIA Canyon 1 or 2 holder in moderate vertical and aquatic canyons.

If you work in the canyon sector as a guide or employer and are interested in an external qualification recognised by industry then talk to NZOIA about the [Affiliated Membership](#) and the [Free Range Assessment](#) model.

Mountain biking

National rafting and riverboarding guiding

Skills Active and the New Zealand Rivers Assn are working together to redevelop the national raft and riverboard guiding qualifications to ensure they continue to meet industry needs.

Education in the outdoors

Education Outdoors New Zealand is bringing its Education outside the Classroom qualification into the New Zealand Certificates framework.

High wire and high ropes

The high wire and high ropes sectors are currently engaged with Skills Active in developing assessor requirements prior to their qualification launch.

Other activities

Skills Active advises that other sector activities such as coasteering, hunting and adventure-based learning are on the horizon for inclusion as activity strands in the national certificates. Although some of these already have their own courses or awards, Skills Active says it will be good to see them get the added recognition they deserve through an NZQA qualification.
